Shannon Produce Farm, Inc., et al.* was whether the Fair Labor Standards Act's (FLSA) provision provides a cause of action to foreign workers located abroad who are denied re-hire in retaliation for exercising their rights under the FLSA. The court ruled that neither the FLSA nor general extraterritoriality principles stand in the way of the plaintiffs' retaliation claim.
